Entry Restrictions	Entry is only open to Australian residents aged 18 years of age or older who have a ticket to attend the GIANTS President's Lounge function at the 2025 AFL Round 24 GIANTS v St Kilda match. There is a limit of one entry per person. Employees (and their immediate families) of the Promoter and agencies associated with this promotion are ineligible to enter.
